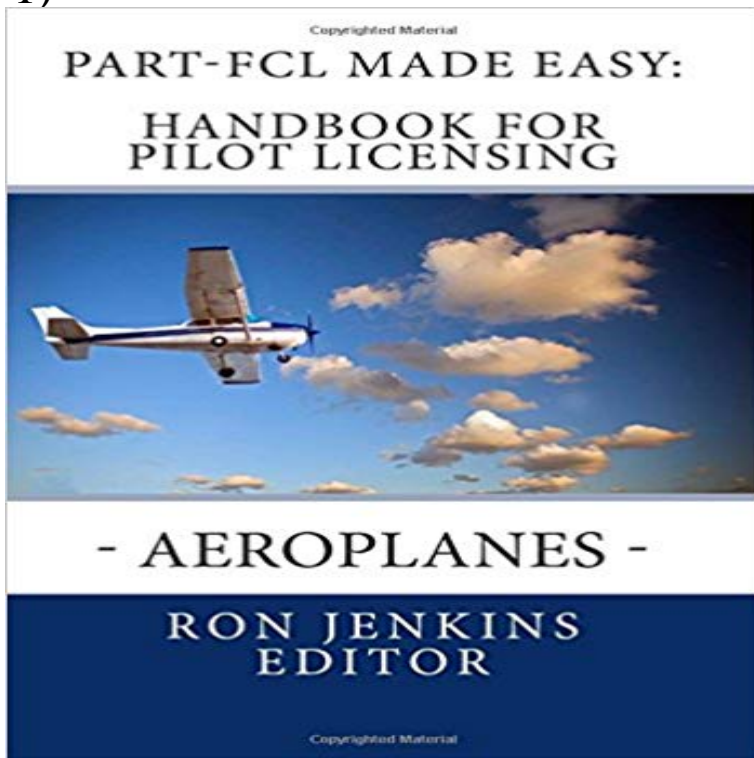

This volume contains all the aircrew licensing requirements applicable to AEROPLANE and TOURING MOTOR GLIDERS and will serve those with a particular interest in becoming a pilot. For those already holding an aeroplane or TMG pilot licence, the book offers detailed explanation on the new EU rules and how to obtain additional licence privileges, or additional qualifications to act, for example, as instructors and examiners. The third edition includes the amendments to the Commission Regulation No. 1178/2011 published in 2014, i.e. the Commission Regulations No. 70/2014 and No. 245/2014. The complete series of books are written in a logical manner, making even the most difficult issues easy to understand. All the references to the official publications are included in the text. Therefore, the books should also serve as a valuable reference for Training Organisations and Competent Authorities.
