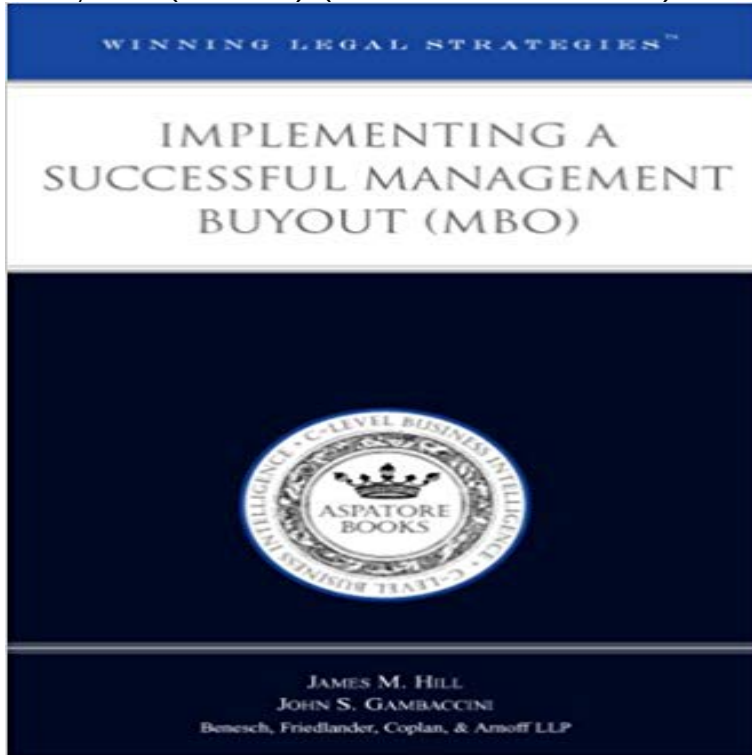


## Winning Legal Strategies: Implementing a Successful Management Buyout (MBO) (Inside the Minds)
