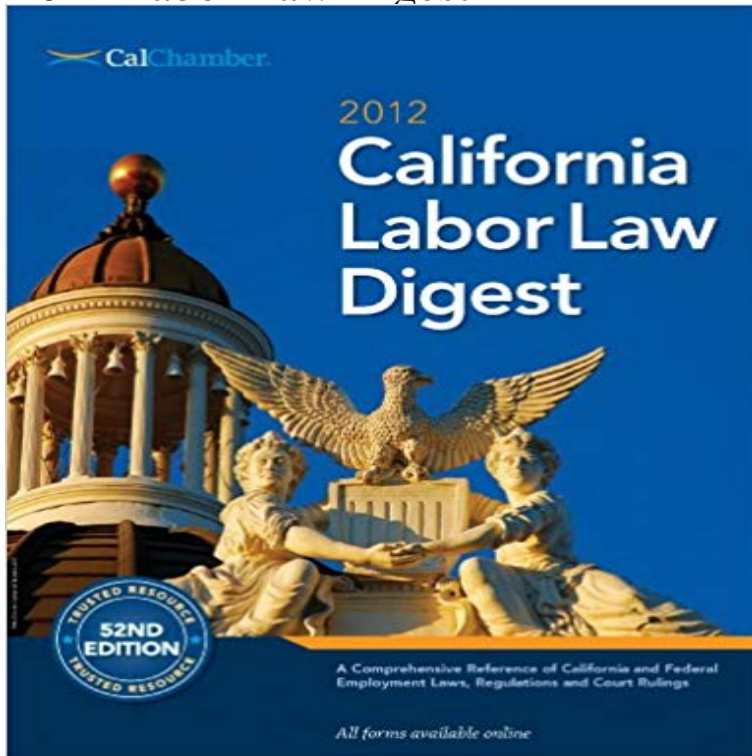


## 2012 Labor Law Digest
