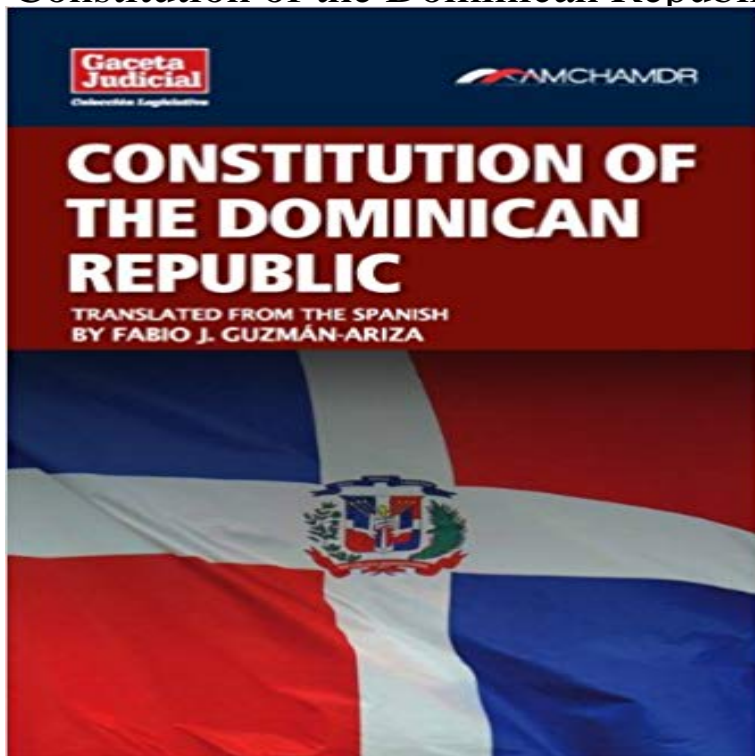


Constitution of the Dominican Republic
