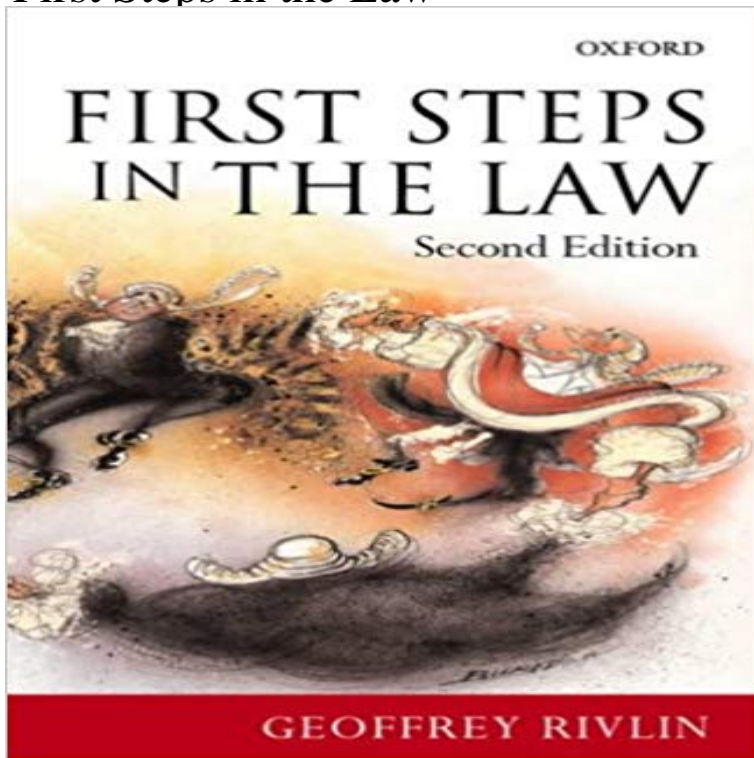


First Steps in the Law
