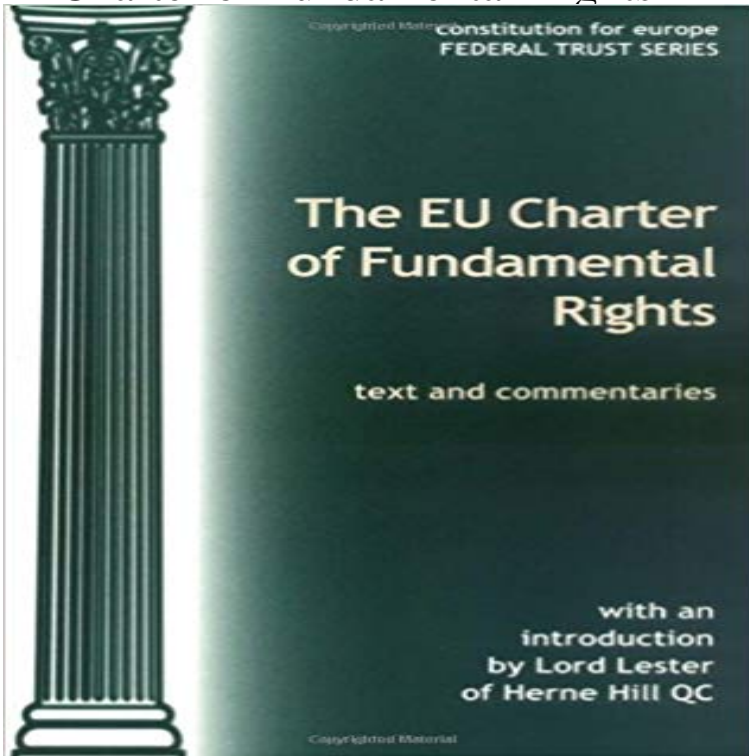


## A Charter of Fundamental Rights
