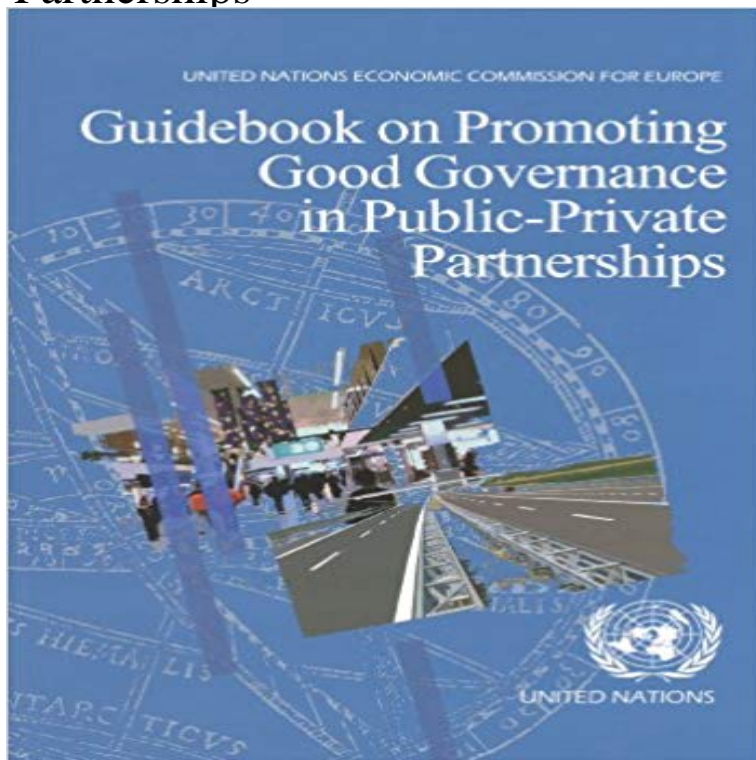


# Guidebook on Promoting Good Governance in Public-Private Partnerships
