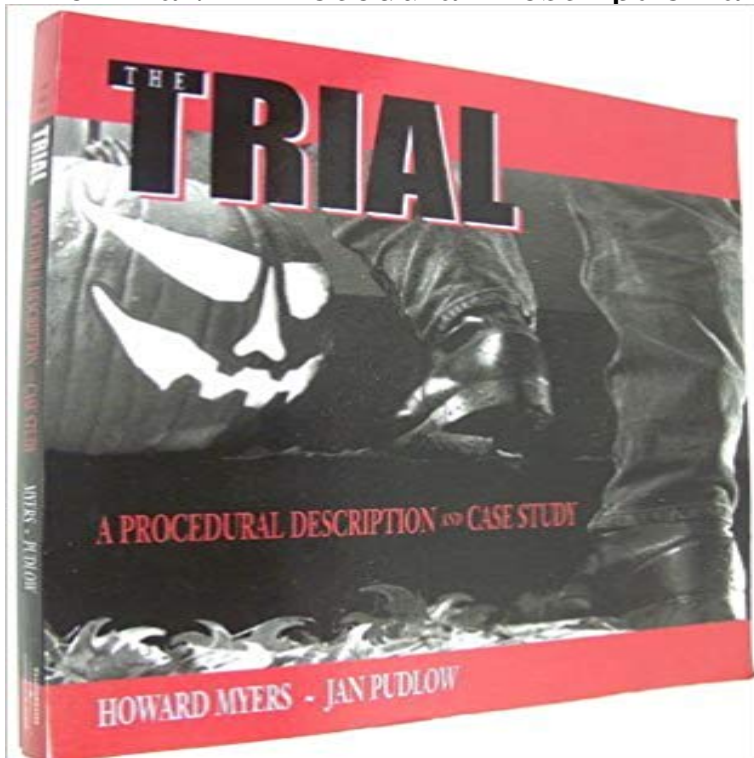


The Trial: A Procedural Description and Case Study [Paperback]
