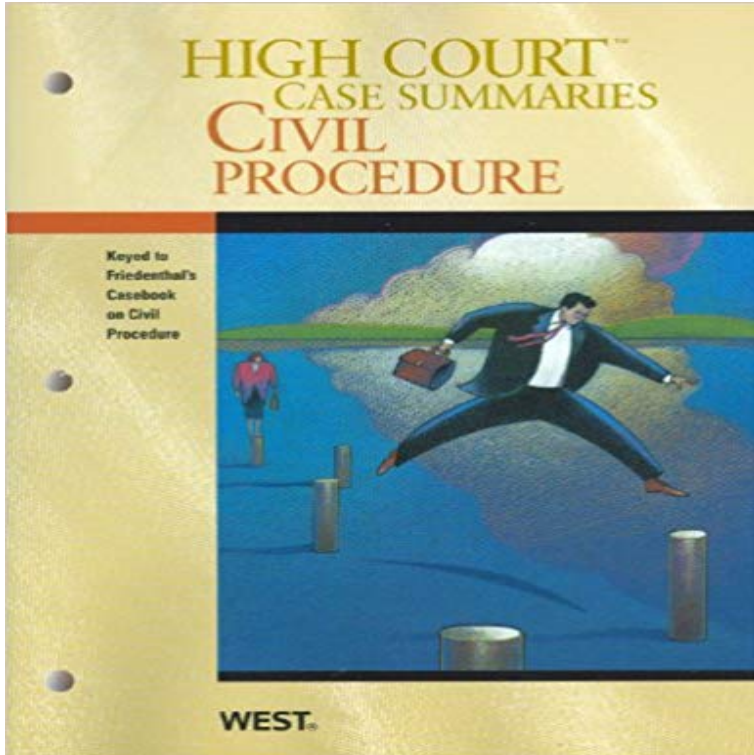


# High Court Case Summaries on Civil Procedure, Keyed to Friedenthal, 10th
