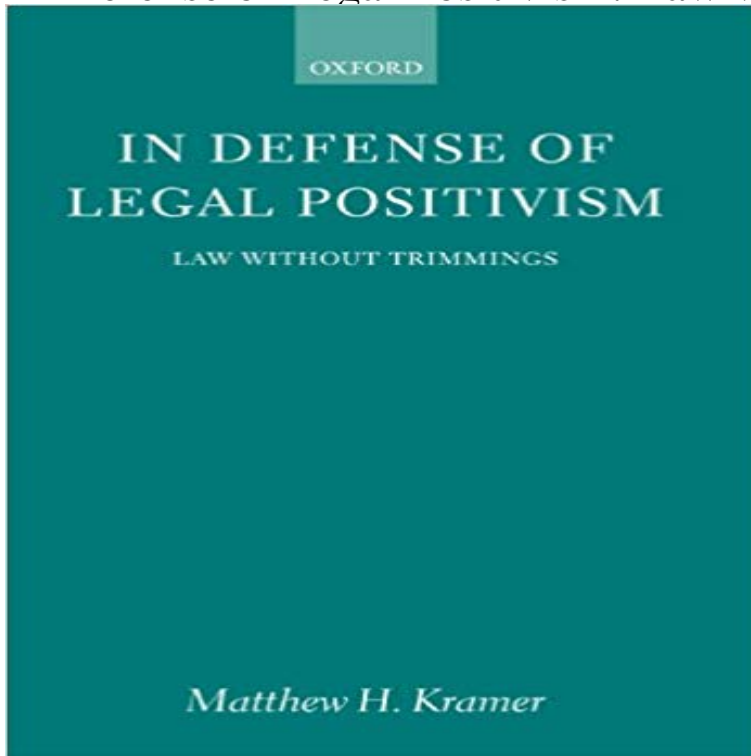


# In Defense of Legal Positivism: Law without Trimmings
