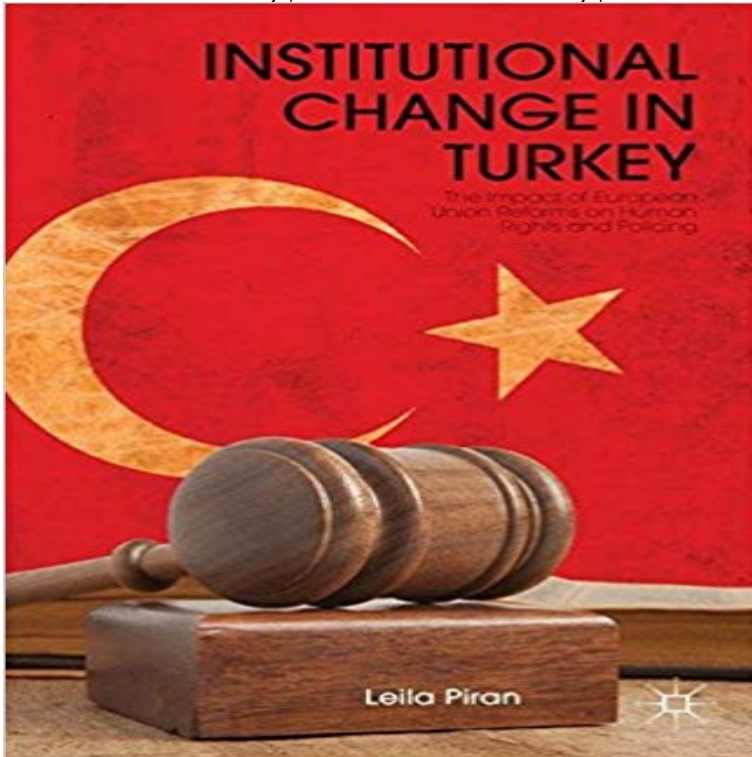


# Institutional Change in Turkey: The Impact of European Union Reforms on Human Rights and Policing
