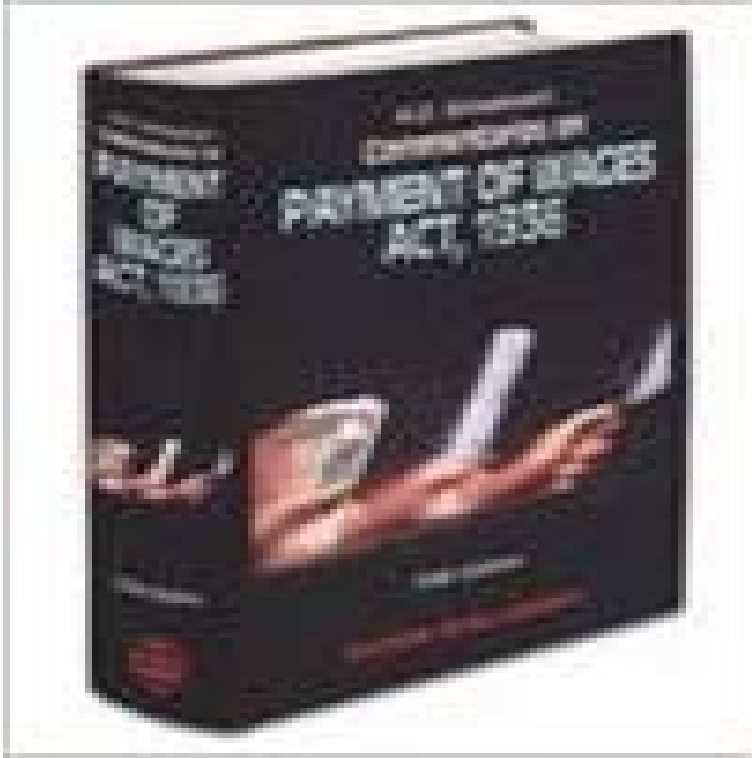


## K.D. Srivastavas Commentaries on Payment of Wages Act, 1936: with Supplement
