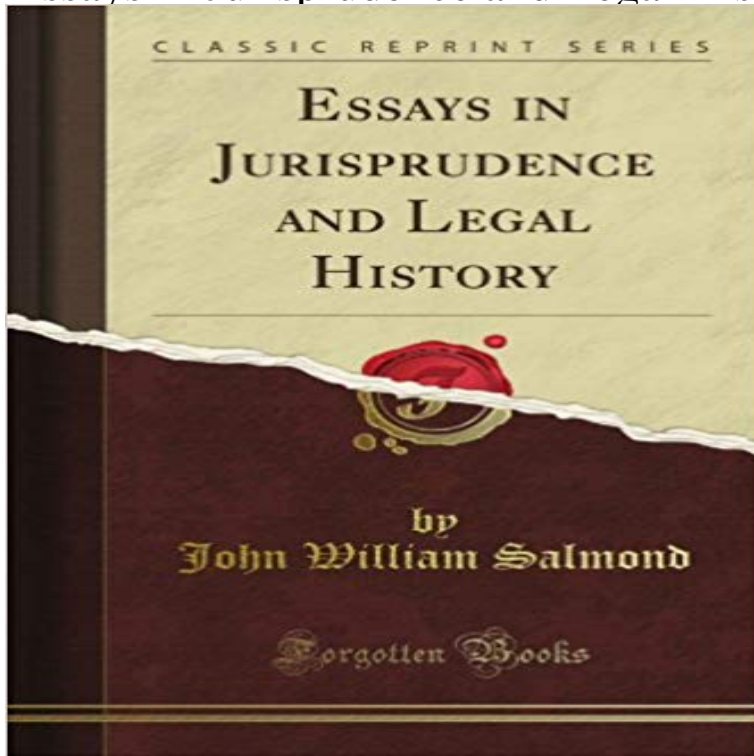

An essential requisite for the discovery of truth is the correct measurement of probative force.
