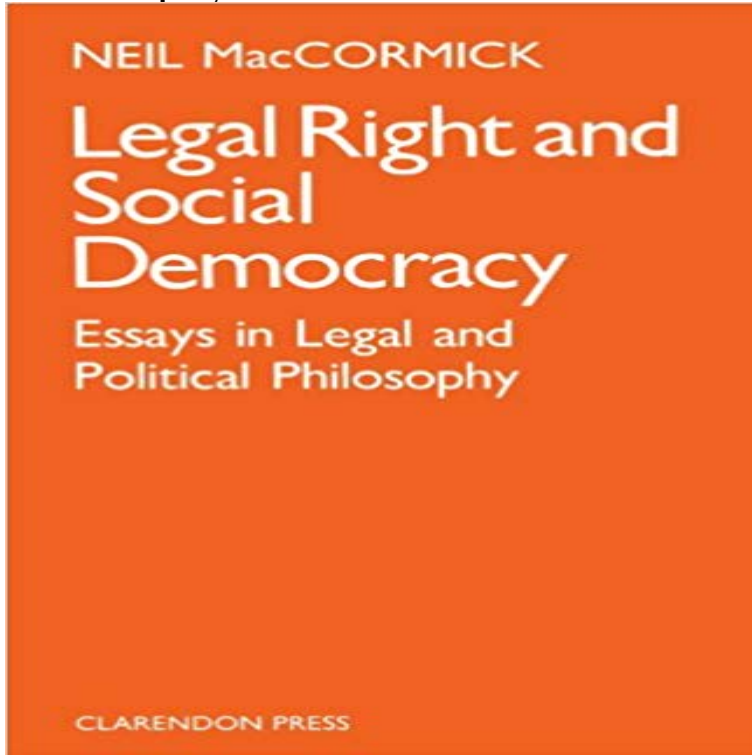


# Legal Right and Social Democracy: Essays in Legal and Political Philosophy
