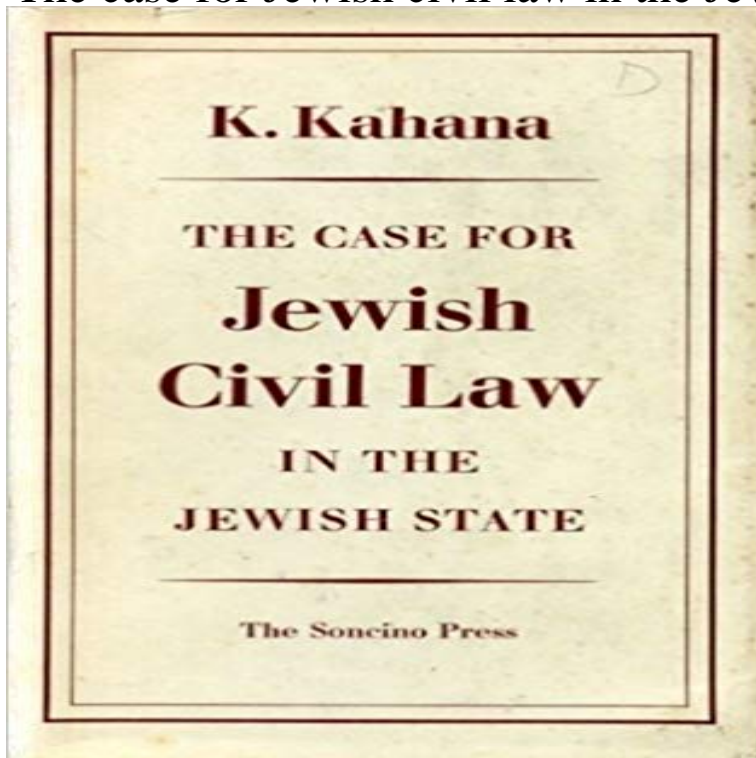


## The case for Jewish civil law in the Jewish State
