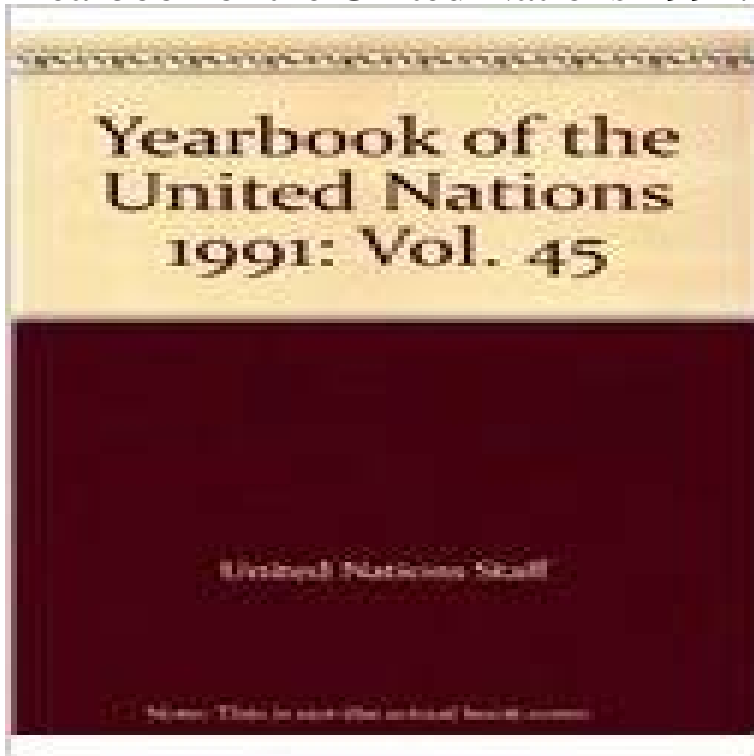


## Yearbook of the United Nations 1991: Vol. 45
