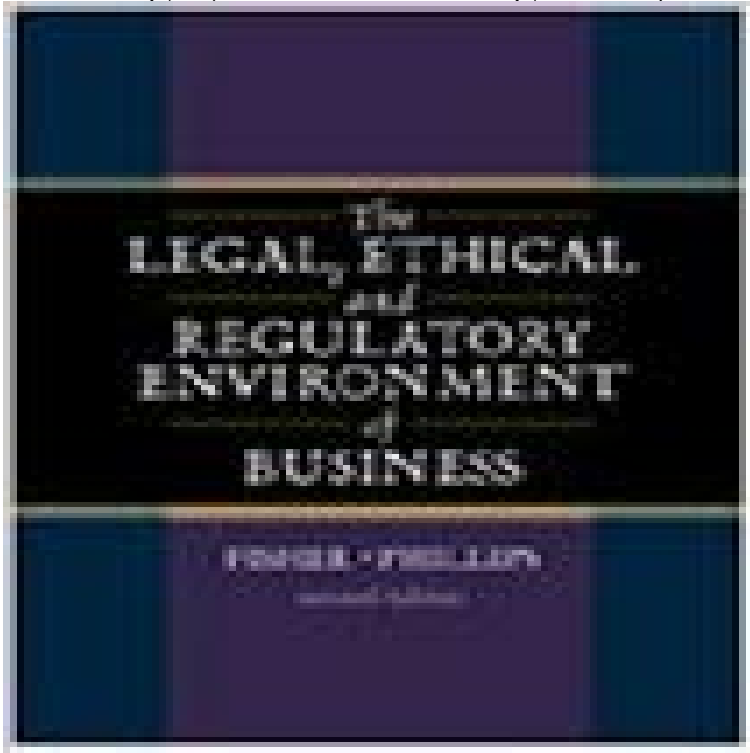


# The Legal, Ethical and Regulatory Environment of Business
