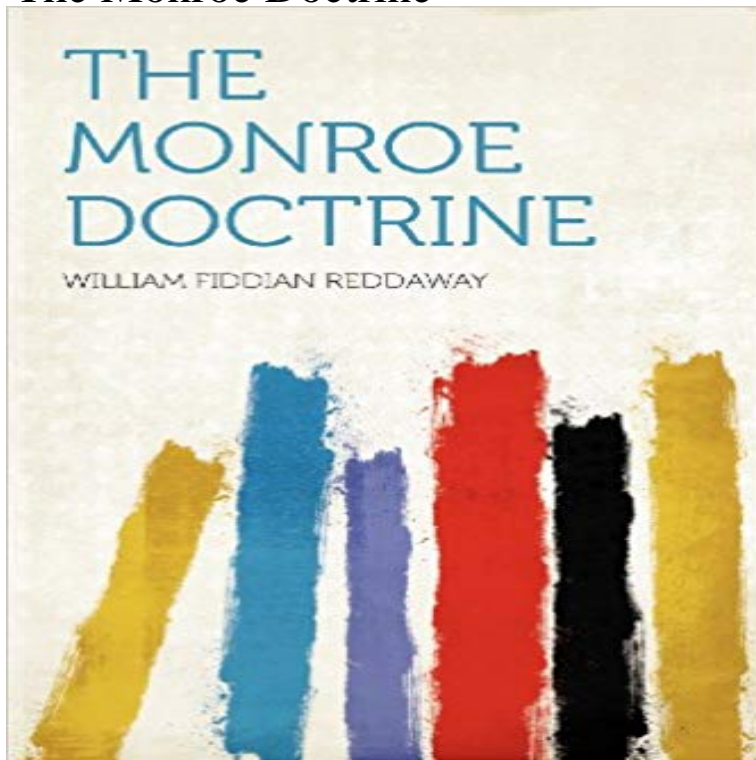


The Monroe Doctrine
