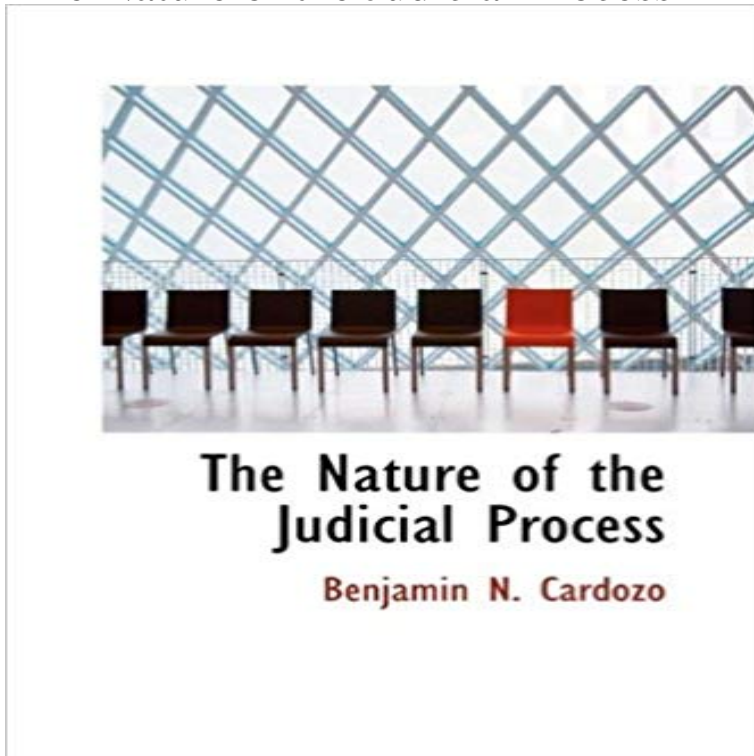


The Nature of the Judicial Process
